**Sub : Block wise quota for new house construction under BAY /PMAY-G (2020-21)..**

In reference to the subject mentioned above, enclosing herewith the Block wise quota (Annexure-A) for new house construction under BAY for the financial year 2020 -2021 for taking appropriate measures to complete the selection of beneficiaries for the scheme as per guidelines. In view of above, following actions are to be followed immediately.

- Cases not in the PMAY-G list will not be considered at present.
- Allotment of house in the name of female member and collection of data regarding **bank a/c details, Name of nominee, Job Card No.**, Mobile No., Aadhaar No. SBM (G) No etc. for feeding in AwaasSoft application.
- Mandatory use of Mobile App for inspection and photo capturing. ( version 2.3.3 or latest version available in Google play store) ( user manual for Mobile App is available at [www.iay.nic.in](http://www.iay.nic.in) )
- No jump in priority list is allowed.
- Arrangement of land for the landless households for construction of house.
- Account details of the beneficiary once frozen will not be changed.
- System generated Sanction order to be issued for each beneficiary.
- 1<sup>st</sup> installment to be released within 7 days from issue of sanction order.

**A few salient features are given for your ready reference.**

- Sensitization of the beneficiaries.
- Minimum unit house size – 25 Sq. m ( 270 sq. ft ) including a dedicated area for hygienic cooking.
- Unit Assistance – Rs.1.20 lakh divided into 3 installments. ( 1<sup>st</sup> inst- Rs.60,000/- ; 2<sup>nd</sup> inst- Rs.50,000/- ; 3<sup>rd</sup> inst- Rs.10,000/- )
- Provision of assistance for toilets.
- Provision of 90 person days of unskilled labour wage under MGNREGS for construction of house over and above the unit assistance.
- Convergence with other Govt. Schemes.
- Provision for permanent deletion of the ineligible beneficiary from the priority list (***In this connection necessary proceedings will strictly be followed as it is an one time process and the beneficiary will be deleted permanently from the database***), please follow the instruction vide Ministry Of Rural Development Departments letter no J-11060/04/2017-RH(A/c) dated 24th Oct 2017 .


