


Cost of Tender Document & Earnest Money may be remitted through Demand Draft/ Pay Order/ Banker's Cheque issued from any Scheduled Commercial Bank in favour of the '**District Engineer, Zilla Parishad, Burdwan**' payable at Burdwan and same may be documented along with Earnest Money through e-filling. (Details of which has been narrated in e-tender guide line). The Cost of Tender Documents and Earnest Money should be sent physically to office of the District Engineer, Zilla Parishad, Burdwan, in sealed cover (with forwarding letter head of the bidder) within **stipulated Date & Time schedule** before Technical Bid opening.

The pre-qualification documents will be opened on by the District Engineer, Burdwan or his authorized representative electronically from the web site. The eligibility criteria are given below:-


- 1) The applicant in the same name and style as prime contractor should have successfully completed at least one contract of same type of work at least one third value of the proposed contract within last five years.
- 2) The contractor should have sufficient technical man power, tools and plants to complete the work.
- 3) The contractor should have necessary bid capacity to execute the work (Documentary evidence in proof of the 2 items should be enclosed).
- 4) Income Tax return should be submitted for last 5 years.
- 5) Copy of Sales Tax , Professional Tax clearance certificate & PAN Card should be furnished. The Amount of Earnest Money & Cost of Tender Document as per notice.

All duties, taxes, royalties, cess, toll, taxes and other levies payable by the Contractor under the Contract to the State/Central Government. For any other cause which shall be included in the rates, prices and total Bid price submitted by the bidder shall also be deducted from successive bill.

To keep the road in good condition during the next 3 years after completion of construction work, if any additional / excess work is required over the stipulated quantity, the same will be treated as defect liability and the Contractor has to execute the maintenance work at his own cost.

Time allowed for completion of work is 9 (Nine) months (excluding rainy season from 14th June to 14th September) from the date of issue of work order.


