- Neither prospective bidders nor any of constituent partner had been debarred to participate in tender by any Govt. Deptt. during the last 5 (five) years prior to the date of this e-NIT. Such debar will be considered as disqualification towards eligibility.

- 4. Constructional Labour Welfare Cess @ 1(one) % of cost of construction will be deducted from every bill of the selected agency. Vat, Royalty & all other statutory levy/ cess will have to be borne by the contractor. The rate in the schedule of rates is inclusive of all taxes & cess stated above.
