For and on behalf of the Zilla Parishad, Burdwan the District Engineer, Burdwan invites sealed offers in two cover system from the bonafide, reputed & resourceful 'Civil Engineering Consultant/Consultancy Firms' for preparation of project proposal consisting of plan, design, drawing, estimate etc. for the following schemes. Credentials of consultancy service of approved scheme/completed scheme of similar nature under PWD /CPWD /Railway /Corporation/Zilla Parishad or any other Govt. Deptt./ Semi Govt. Deptt executed during last five year as prime agency are required to be submitted along with offer.

Rate should be quoted in percentage basis on Project Estimated Amount of the proposal which will include all taxes, duties & other charges, as applicable. No price variation clause will be entertained. Offers shall remain valid for period not less than 120 (one hundred twenty) days from the date of opening of Financial proposal. Tenderers are also requested to follow the 'Instruction to the Offerers', 'Scope of work' etc before offering their rate.

Difficulties & peculiarities as prevailing at the site of the work to be considered while offering their rate. No claim for any additional charges, if any, shall be entertained. Offer without Earnest Money shall not be accepted. Earnest Money for successful Tenderer shall be return only on application after executing an agreement. For unsuccessful Tenderers, the same will be return back on application. Performance Security deposit of Rs.10,000/- (Rupees Ten thousand only) shall also required to submitted through Bank Guarantee/ duly pledged Fixed Deposit Certificate issued from any schedule bank at the time of executing agreement and the same shall be release after 2 (two) years from the date of work order or payment of final bill for the work whichever is earlier. No other security deposit shall be deducted from the successive bills for the service. Successful Tenderer should have required to execute an agreement in Non-Judicial Stamped paper worth Rs. 10/- (Ten) within 7 (seven) days from the date of issue of the work order as per norms. Time is the essence of the contract failing which the order shall be liable to be terminated and the party shall be debarred from participating in future tender.
