3. Eligibility criteria for participation in tender:

- The prospective bidders shall have satisfactorily completed as prime agency one similar nature of work equal to at least 75% (seventy five percent) value for which bid is invited during the last 5(five) years prior to the date of issue of this notice, under Zilla Parishad, P.W.D., C.P.W.D., & similar other Govt. Deptt. Copy of completion certificate (for executed work) obtained from not below the rank of the Work Order issuing authority should be produced with the technical bid. The bidder should have to produce ownership documents of necessary machineries required for the work & also required to submit bar chart for the work along with their bid.
- ii) a) PAN Card b) Current Professional Tax Receipt Challan c) VAT Registration Certificate d) Current Income Tax acknowledgement Receipt. [Non Statutory Documents].
