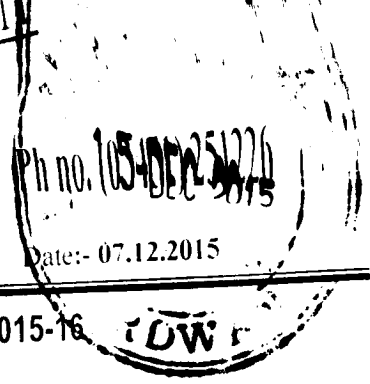

Eligibility of Contractor: Having credential in the form of payment certificate for completing similar type of work for at least 50(fifty) % of the amount put to tender within last 5 years i.e. 2010-11, 2011-12, 2012-13, 2013-14 & 2014-15 in a single work (Similar type of work). Credential from any Govt. /Semi Govt. and from autonomous bodies as prime contractor will be entertained for schemes having completion certificate as proof of credential.

1. The intending tenders if found himself eligible to participate in the tender, should download the details tender notice along with tender documents from wbtenders.gov.in the cost of tender documents, Tender processing etc. and the Earnest Money Depositer (EMD) as specified should be deposited in the form of Demand Draft (DD) drawn in favour of **Executive Officer, Raina-II Panchayat Samity, Payable at Bataspur**. The scanned copy of the DD must be uploaded at the time of online bid submission. In addition to uploading the scanned copy of the relevant documents with the original DD, would have to be dropped in the Tender Box kept at the Raina-II Panchayat Samity Office in sealed envelope clearly super scribing the NIT NO. Name & Sl. No. of the works. Name of bidder within the following date & time. Without uploading /submission of either the scanned copy or the original DD, the tenders will be treated as non-responsible. The tenderers will have to submit their bid online. In two cover folder system containing pre-qualification documents (technical bid) in one and financial bid in another. The documents submitted by the bidder should be properly indexed and digital signed. The Tenderers who was participated in the Notice Inviting e-Tender no- **02(4)/Raina-II P.S/2015-16, (for Sl no- 02, 03 & 04)** & e-Tender (Retender) no- **03(3)/Raina-II P.S/2015-16, (for Sl no- 01, 02 & 03)** need not deposit cost of the Earnest Money Depositer (EMD) if they intend to participate in this e-Tender. But the scanned copy of the DD must be uploaded at the time of online bid submission.

2. Eligibility criteria for participating e-tender :

(a) The bidders shall have satisfactory completed as a **prime agency** during the last 5 years from the date of issue of this notice at least one work of similar nature under the authority of State/Central Govt., State/Central Govt. under taking. Statutory bodies constituted under the statute of the Central/ State Govt. and having a magnitude of 50(fifty) % of the amount put tender. (The completion certificate and detail communicational address of the client must be indicated in the credential certificate. *(Ann- Statutory Documents)*)

- 3) P. Tax deposit challan for the year of 2015-16, PAN Card, VAT Registration Certificate has to be accompanied with the technical bid document. *(Non-Statutory Documents)*
- 4) Registered Partner Ship Deed in case of partner ship firm has to be submitted. The Company shall furnish the Article of Association and Memorandum. Where an individual person holds a digital certificate in his own name duly issued to him against the company or the firm of which he happens to be a director or partner, such individual person shall, where uploading any tender for an behalf of company or firm, invariably upload a copy of registered power of attorney showing clear authorization in his favour, by the rest of the director of such company or the partners of such firm to upload such tender. *(Non-Statutory Documents)*
- 5) **Joint venture will not be allowed.**
- 6) The tenderer shall established field testing laboratory equipped with requisite instrument and technical staffs according to the requirements of works to be executed.
- 7) Payment will be made as a when fund is available from the concern source. No claim whatsoever for dealing payment, if any will be entertained. **Bill (including final bill) will be paid for this work as per fund available.** Contractors are requested to quote their rate accordingly.
- 8) No arbitration is allowed in this contract.
- 9) 10 (Ten) % value of the work will be retained as security deposit which will be released after 6 (Six) Months from successful completion project. Agencies have to arrange land for direction of Plant & Machineries, storing of materials labour shed, Lab rotary etc. water and electricity at their won cost and responsibility.
10. No material will be issued from the department.
- 11) Necessary Taxes will be deducted as per Govt. norms and Constructional labour welfare cess at 1% of the bill value will be deducted from every bill.
- 12) Contractors shall have to comply with the provisions of A) the contract labour (regulation Abolition) Act, 1917 B) apprentice Act 1961 & C) Minimum wages Act, 1948 of the notification there of or any laws relating there to and the rules made and order issued there under from time to time.
- 13) The schedule of rates: as given in BOQ.
- 14) During scrutiny if it comes to notice of the tender inviting authority that the credential or any other paper found incorrect/manufacture/fabricated, that bidder would not be allowed to participate in the tender and that application will be rejected without any prejudice.
- 15) The authority reserves the right to cancel the NIT due to unavoidable circumstance and for the no claim will be entertained.
- 16) Bids shall remain valid for a period not less than 45(forty five days) days from the last date of submission of Financial Bid. If the bidder withdraws the bid during the validity period of bid, the earnest money as deposited will be forfeited forthwith without assigning any reason thereof.
17. Before submission of tender, the tenderer shall have to acquaint by actual visit to the site as regards prevailing conditions and tenderer submitting tender shall be deemed to have done so. He must acquaint himself with local conditions of labour, material, transport, electricity, water, Panchayat regulations etc.
18. It will be contractor's responsibility to keep the road open to all kind of traffic during the execution of work. No Claim whatsoever will be entertained for idle labour, establishment cost of hire & labour charges of tools & plants etc. at any circumstances.

25. All tools, plants & machineries including vibratory, road roller etc. required to execute the Contract, has to be arranged by Contractor at his own cost.
