**Eligibility of Contractor:** Having credential in the form of payment certificate for completing similar type of work for at least 40(forty) % of the amount put to tender within last 5 years i.e. 2010-11, 2011-12, 2012-13, 2013-14 & 2014-15 in a single work (Similar type of work). Credential from any Govt. /Semi Govt. and from autonomous bodies as prime contractor will be entertained for schemes having completion certificate as proof of credential.

1. The intending tenders if found himself eligible to participate in the tender, should download the details tender notice along with tender documents from [wbtenders.gov.in](http://wbtenders.gov.in) directly with the help of Digital Signature Certificate. The cost of tender documents, Tender processing etc. and the Earnest Money Deposit( EMD) as specified should be deposited in the form of Demand Draft (DD) drawn in favour of **Block Development Officer, Raina-II Development Block, Payable at Bataspur**. The scanned copy of the DD (EMD) must be uploaded at the time of online bid submission. In addition to uploading the scanned copy of the DD, the original part of online submission of EMD, should be submitted physically to the office of the Block Development Officer, Raina-II Development Block by the lowest bidder after opening of the bid within the stipulated date which will be mentioned and uploaded online by the tendering authority after financial evaluation. Without uploading /submission of either the scanned copy or the original DD, the tenders will be treated as non-responsible. The tenderers will have to submit their bid online in two cover folder system containing pre-qualification documents (technical bid) in one and financial bid in another. The documents submitted by the bidder should be properly indexed and digital signed.
