Copy of completion certificate (for executed work) obtained from not below the rank of the Work Order issuing authority should be produced with the technical bid.(N.B.- Estimated amount, work done amount, date of completion of work and detailed communicational address of the client must be indicated in the credential certificate). The bidder should have submit proper Bar Chart for the work along with their bid.
- a) PAN Card b) Current Professional Tax Receipt Challan c) VAT Registration Certificate ii) d) Current Income Tax acknowledgement Receipt. [Non Statutory Documents].
- Neither prospective bidders nor any of constituent partner had been debarred to participate in tender by any iii) Govt. Deptt. during the last 5 (five) years prior to the date of this e-NIT. Such debar will be considered as disqualification towards eligibility.
