- iii) Neither prospective bidders nor any of constituent partner had been debarred to participate in tender by any

- ix) Where there is a discrepancy between the unit rate & the line item total resulting from multiplying the unit rate by quantity, the unit rate quoted shall govern.

- 4. <u>Constructional Labour Welfare Cess</u> @ 1(one) % of cost of construction will be deducted from every bill of the selected agency. - 17. In case of quoting rates, no multiple lowest rate will be entertained by the Department.
- 18. The District Engineer, Bardhaman Zilla Parishad reserves the right to cancel the e-N.I.T. due to unavoidable circumstances and no claim in this respect will be entertained.
