- In the event of e-filing intending bidder may download the document from the web-site directly by the help of digital signature certificate and necessary Cost of Tender Document & Earnest Money may be remitted through Demand Draft/ Pay Order/ Banker's Cheque issued from any Scheduled Commercial Bank in favour of the **District Engineer, Purba Bardhaman Zilla Parishad** payable at **Bardhaman** and same may be documented through e-filing. (Details of which has been narrated in "Instructions to Bidders")
- The Cost of Tender Documents & Earnest Money should be sent physically to the office of the District Engineer, Purba Bardhaman Zilla Parishad, along with a forwarding letter under sealed cover within stipulated **Date & Time schedule** before Technical Bid opening. Failure to submit hard copies of Demand Draft/ Pay Order/ Banker's Cheque within the time period by any bidder, shall be debarred from participating any tender of the Zilla Parishad for 6 (six) months from the scheduled Date of opening of Financial Bid of this tender. Both Technical Bid & Financial Bid will have to be submitted concurrently duly digitally signed in the Govt. Web-site <https://wbtennders.gov.in>. Tender document may be downloaded from web-site and submission of Technical Bid/Financial Bid will be done as per tender schedule stated in Sl. No. 9.
The documents submitted by the Bidders should be properly indexed and be self attested with seal.
- Eligibility criteria for participation in tender:**
 - The prospective bidders shall have satisfactorily completed as prime agency atleast one similar nature of work having minimum value of one third of the estimated cost for which bid is invited during the last 3(Three) years prior to the date of issue of this notice, under Zilla Parishad, P.W.D., C.P.W.D., & similar other Govt. Deptt. Copy of completion certificate (for executed work) obtained from not below the rank of the Work Order issuing authority should be produced with the technical bid.(N.B.- Estimated amount, work done amount, date of completion of work and detailed communicational address of the client must be indicated in the credential certificate). The bidder should have to proper submit Bar Chart for the work along with their bid.
 - a) PAN Card b) Current Professional Tax Receipt Challan c) Valid 15-digit Goods & Services Taxpayer Identification Number (GSTIN) under GST Act,2017 d) Current Income Tax acknowledgement Receipt.e) Trade Licence. [Non Statutory Documents].
 - Neither prospective bidders nor any of constituent partner had been debarred to participate in tender by any Govt. Deptt. during the last 5 (five) years prior to the date of this e-NIT. Such debar will be considered as disqualification towards eligibility.
 - Registered Unemployed Engineers' co-operative Societies/ Unemployed Labour Co-Operative Societies are required to furnish Valid Bye Law, Valid Register Certificate issued by the Co-operative Department,

Current Audit Report, Annual General Meeting along with other relevant supporting papers. [Non Statutory Documents].


- v) A prospective bidder shall be allowed to participate in the job either in the capacity of individual or as a partner of a firm. If found to have applied severally in a single job, all his applicants will be rejected for that job only.
 - vi) A prospective bidder (including his participation in partnership) shall be allowed to participate maximum three works as mentioned in the list of schemes. If bid is received for more than three works, first three consecutive serial will be considered for evaluation and others bid will be rejected.
 - vii) The Partnership firm shall furnish the registered partnership deed and the company shall furnish the Article of Association and Memorandum. [Non Statutory Documents].
 - viii) Where there is a discrepancy between the rate in figures & words, the rate in words will govern.
 - ix) Where there is a discrepancy between the unit rate & the line item total resulting from multiplying the unit rate by quantity, the unit rate quoted shall govern.
 - x) Any change of BOQ will not be accepted under any circumstances.
 - xi) Tax invoice(s) needs to be issued by the supplier for raising claim under the contract showing separately the tax charged in accordance with the provisions of GST Act, 2017. (As applicable)
4. Constructional Labour Welfare Cess @ 1(one) % of cost of construction will be deducted from every bill of the selected agency. GST, Royalty & all other Statutory levy/ Cess will have to be borne by the contractor & the rate in the schedule of rates inclusive of all the taxes, cess & all other charges etc. Necessary deduction will be made from the contractor's bills as per prevailing Govt. orders and rules towards security deposit & other taxes & charges etc.
 5. The Agency shall quote their rate in percentage basis i.e. Excess /Less/At par (Both in figures as well as in words) in the given space of Financial Bid Documents only.
 6. a) No Mobilization Advance and Secured Advance will be allowed.
b) No Price Variation will be allowed.
 7. Agency shall have to arrange land for creation of Plant & Machineries, storing of materials, labour shed, laboratory etc. at their own cost and responsibility.
 8. Bids shall remain valid for period not less than 120 (one hundred twenty) days from the date of opening of Financial Bid. "Bid valid for a shorter period shall be rejected by the 'Purba Bardhaman Zilla Parishad' as non response".

10. There shall be no provision of Arbitration.
11. Cost of Tender Documents & Earnest Money: The Cost of tender documents & amount of earnest money will be in the shape of Bank Draft/Pay Order/ Banker's Cheque of any scheduled Commercial Bank drawn in favour of the '**District Engineer, Purba Bardhaman Zilla Parishad** payable at **Bardhaman**.
12. The Bidder, at the Bidder's own responsibility and risk is encouraged to visit and examine the site of works and its surroundings and obtain all information that may be necessary for preparing the Bid and entering into a contract for the work as mentioned in the e-Notice Inviting Tender, the cost of visiting the site shall be at the Bidder's own expense.
13. The intending Bidders shall clearly understand that whatever may be outcome of the present invitation of Bids, no cost of Bidding shall be reimbursable by the Department. Purba Bardhaman Zilla Parishad reserves the right to accept or reject any offer without assigning any reason whatsoever and is not liable for any cost that might have incurred by any Bidder at the stage of bidding.
14. Prospective applications are advised to note carefully the minimum qualification criteria as mentioned in "Instructions to Bidders" before bidding.
15. In case of Ascertaining Authority at any stage of application or execution of work necessary registered power of attorney is to be produced.
16. **No CONDITIONAL/INCOMPLETE TENDER** will be accepted under any circumstances.
17. In case of quoting rates, no multiple lowest rate will be entertained by the Department.

18. The District Engineer, Purba Bardhaman Zilla Parishad reserves the right to cancel the e-N.I.T. due to unavoidable circumstances and no claim in this respect will be entertained.
19. During scrutiny, if it is come to the notice to tender inviting authority that the credential or any other papers found incorrect/manufactured/fabricated, that tenders will not be allowed to participate in the tender and that application will be out rightly rejected without any prejudice.
20. Before issuance of the work order, the tender inviting authority may verify the credential & other documents of the lowest tenderer, if found necessary. After verification, if it is found that such documents submitted by the lowest tenderer, is either manufactured or false, in that case work order will not be issued in favour of the tenderer under any circumstances.
21. Bid from Joint Venture are not allowed.
22. The Defects Liabilities period for the work is two year from completion date.
23. In case of any change of date, corrigenda, addenda, due intimation will be given in web site/ Notice Board


