(Details of which has been narrated in e-tender guide line). The Cost of Tender Documents and Earnest Money should be sent physically to the office of District Engineer, Purba Bardhaman Zilla Parishad, Bardhaman, in sealed cover (with forwarding letter head of the bidder) within stipulated Date & Time schedule before Technical Bid opening. Failure to submit hard copies of Demand Draft/ Pay Order/ Banker's Cheque within the time period by any bidder, shall be debarred from participating any tender of the Zilla Parishad for 6 (six) months from the scheduled date of opening of Financial Bid of this tender.

The pre-qualification documents will be opened on by the District Engineer, Purba Bardhaman Zilla Parishad or his authorized representative electronically from the web site. While evaluation, District Engineer, Purba Bardhaman Zilla Parishad may call the bidders & seek clarification/ information or additional documents or original copy of any of the documents already submitted & if these are not produced within the stipulated time frame, their proposals will be liable for rejection.

The financial bid document of the technically qualified bidders will be opened for evaluation and selection of qualified bidders on and the other bid documents will remain unopened. No separate intimation will be given for this, unless the above date is changed. In case of change of date, due intimation will be given in Web-site as well as in the Notice Board of the office of the undersigned. No individual intimation will be given. Name of the qualified bidders will be displayed in the web site as well as at the office Notice Board of the undersigned.

The eligibility criteria are given below:-

- 1) The applicant in the same name and style as prime contractor should have successfully completed at least one contract of same type of work at least one third value of the proposed contract within last five years from the date of publication of notice.
- 2) The contractor should have sufficient technical man power, tools and plants to complete the work.
- 3) The contractor should have necessary bid capacity to execute the work (Documentary evidence in proof of the 2 items should be enclosed).
- 4) Income Tax return should be submitted for last 5 years.
- 5) Copy of Sales Tax , Professional Tax clearance certificate , PAN Card & Valid 15-digit Goods & Services Taxpayer Identification Number (GSTIN) under GST Act,2017 should be furnished. The Amount of Earnest Money & Cost of Tender Document as per notice.

All applicable duties, taxes, royalties, cess, toll and other statutory levies is payable by the Contractor under the Contract to the State/Central Government. For any other cause which shall be included in the rates, prices and total Bid price submitted by the bidder shall also be deducted from successive bill.


To keep the road in good condition during the next 3 years after completion of construction work ,if any additional / excess work is required over the stipulated quantity, the same will be treated as defect liability and the Contractor has to execute the maintenance work at his own cost.

Time allowed for completion of each work is 9 (Nine) months (excluding rainy season from 14th June to 14th September) from the date of issue of work order.

The intending bidders are requested to inspect the alignment of the proposed road before quoting their rates.


