Tender document may be downloaded from web-site and submission of Technical Bid/Financial Bid will be done as per tender schedule stated in Sl. No. 9.

The documents submitted by the Bidders should be properly indexed and be self attested with seal.

The bidder should have to submit work programme for the work along with their bid.
