Both Technical Bid & Financial Bid will have to be submitted concurrently duly digitally signed in the Govt. Web-site https://etender.wb.nic.in. Tender document may be downloaded from web-site and submission of Technical Bid/Financial Bid will be done as per tender schedule stated in Sl. No. 9.

The documents submitted by the Bidders should be properly indexed and be self attested with seal.

3. Eligibility criteria for participation in tender:

- The prospective bidders shall have satisfactorily completed as prime agency at least one similar nature of work having minimum value of one third of the estimated cost for which bid is invited during the last 3(three) years prior to the date of issue of this notice, under Zilla Parishad, P.W.D., C.P.W.D., & similar other Govt. Deptt. Copy of completion certificate (for executed work) obtained from not below the rank of the Work Order issuing authority should be produced with the technical bid.(N.B.- Estimated amount, work done amount, date of completion of work and detailed communicational address of the client must be indicated in the credential certificate).
- ii) a) PAN Card b) Current Professional Tax Receipt Challan c) Valid 15-digit Goods & Services Taxpayer Identification Number (GSTIN) under GST Act,2017 d) Current Income Tax acknowledgement Receipt.e) Trade Licence. [Non Statutory Documents].
- Neither prospective bidders nor any of constituent partner had been debarred to participate in tender by any Govt. Deptt. during the last 5 (five) years prior to the date of this e-NIT. Such debar will be considered as disqualification towards eligibility.
