3. Eligibility criteria for participation in tender:

The prospective bidders shall have satisfactorily completed as prime agency atleast one similar nature of Supply & Delivery having minimum value of twenty lakh for which bid is invited during the last 5(five) years prior to the date of issue of this notice, under Govt. Deptt. Copy of completion certificate (for executed Supply work) obtained from not below the rank of the work order issuing authority should be produced with the technical bid.(N.B.- work done amount and detailed communicational address of the client must be indicated in the credential certificate


A prospective bidder (including his participation in partnership) shall be allowed to participate maximum v) one work as mentioned in the list of schemes.(Not Applicable)
