#### SECTION - A

1. General guidance for e-Tendering

2. Registration of Contractor

Any contractor willing to take part in the process of e-tendering will have to be enrolled & registered with the Government e-Procurement system, through logging on to https://wbetenders.gov.in. the contractor is to click on the link for e-Tendering site as given on the web portal.

3. Digital Signature certificate (DSC)/e-Token

Each contractor is required to obtain aDigital Signature Certificate (DSC)/ e-Token for submission of tenders from the approved service provider of the National InformationCentre(NIC) on payment of requisite amount, details are available at the Web Site.

The Contractor can search &download e-NIT & Tender Documents electronically from computer once he logs on to the website mentioned in clause 2 using the Digital Signature Certificate)/ e-Token. This is the only mode of collection of Tender Documents.
