Earnest Money Depositof e-Procurement

Online receipt and refund of Earnest Money Deposit of e-Procurement through State Government e-Procurement portal. The following procedure to be adopted for deposit of EMD/Bid Security/Tender Fees related to e-Procurement.

A) Login By bidder :-

- a) A bidder desirous of taking part in a tender shall logging to the e-Procurement portal of the Government of West Bengal :https://wbtenders.gov.in. using his login ID and password.
- b) He will select the tender to bid and initiate payment of pre-defined EMD / Tender Fees for that tender by selecting from either of the following payments modes :-

- i) Net Banking (any of the Banks listed in the ICICI Bank Payment-gateway) in case of payment through ICICI BankPayment Gateway.

B) Payment Procedure:-

- b) Bidder will make the payment after entering his Unique ID and password of the bank to process the transaction.
- c) Bidder will receive a confirmation message regarding success/ failure of the transaction.

SECTION - A

1. General guidance for e-Tendering

Instructions / Guidelines for tenders for electronic submission of the tenders online have been annexed for assisting the contractors to participate in e-Tendering.

2. Registration of Contractor

Any contractor willing to take part in the process of e-tendering will have to be enrolled & registered with the Government e-Procurement system, through logging on to <u>https://wbetenders.gov.in</u>. (the web portal of P & R.D. Department) the contractor is to click on the link for e-Tendering site as given on the web portal.

3. Digital Signature certificate (DSC)/e-Token

Each contractor is required to obtain aDigital Signature Certificate (DSC)/ e-Token for submission of tenders from the approved service provider of the National InformationCentre(NIC) on payment of requisite amount, details are available at the Web Site.

 The Contractor can search &download e-NIT & Tender Documents electronically from computer once he logs on to the website mentioned in clause 2 using the Digital Signature Certificate)/ e-Token. This is the only mode of collection of Tender Documents.

5. Participation in more than one work

A prospective tenderer shall be allowed to participate in the work either in the capacity of individual or as a partner of a firm. If he is found to have applied severally in a single work all his applicants will be rejected for the work.
