#### Earnest Money Depositof e-Procurement

Online receipt and refund of EarnestMoneyDeposit of e-Procurement through State Government e-Procurement portal. The following procedure to be adopted for deposit of EMD/Bid Security/Tender Feesrelated to e-Procurement.

#### A) Login By bidder :-

- a) A bidder desirous of taking part in a tender shall logging to the e-Procurement portal of the Government of West Bengal: <a href="https://wbtenders.gov.in">https://wbtenders.gov.in</a>. using his login ID and password.
- b) He will select the tender to bid and initiate payment of pre-defined EMD / Tender Fees for that tender by selecting from either of the following payments modes:

- c) Bidder will receive a confirmation message regarding success/ failure of the transaction.

- e) If the transaction is failure the bidder will again try for payment by going back to the firststep.

#### ii) Payment through RTGS/NEFT:-

After opening of the bids and technical evaluation of the same by the tender inviting authority through electronic processing in the e-Procurement portal of the State Government, the tender inviting authority will declare the status of the bids as successful/unsuccessful which will be made available, along with the details of the unsuccessful bidders to ICICI bank by the e-Procurement portal through web services.

1. General guidance for e-Tendering

Instructions / Guidelines for tenders for electronic submission of the tenders online have been annexed for assisting the contractors to participate in e-Tendering.

2. Registration of Contractor

Any contractor willing to take part in the process of e-tendering will have to be enrolled & registered with the Government e-Procurement system, through logging on to <a href="https://wbetenders.gov.in">https://wbetenders.gov.in</a>. (the web portal of P & R.D. Department) the contractor is to click on the link for e-Tendering site as given on the web portal.

3. Digital Signature certificate (DSC)/e-Token

Each contractor is required to obtain aDigital Signature Certificate (DSC)/ e-Token for submission of tenders from the approved service provider of the National InformationCentre(NIC) on payment of requisite amount, details are available at the Web Site.

4. The Contractor can search &download e-NIT & Tender Documents electronically from computer once he logs on to the website mentioned in clause 2 using the Digital Signature Certificate)/ e-Token. This is the only mode of collection of Tender Documents.

5. Participation in more than one work

A prospective tenderer shall be allowed to participate in the work either in the capacity of individual or as a partner of a firm. If he is found to have applied severally in a single work all his applicants will be rejected for the work.

6. Submission of Tenders.

General process of submission: - Tenders are to be submitted online through online the website in two folders at a time for each work, one is Technical Proposal & the other is Financial Proposal before the prescribed date & time using the Digital Signature Certificate (DSC). The documents are to be uploaded virus scanned copy duly Digitally signed. The documents will get encrypted (transformed into non readable formats)
