- He will select the tender to bid and initiate payment of pre-defined EMD / Tender Fees for that tender by selecting from b) either of the following payments modes :-
 - Net Banking (any of the Banks listed in the ICICI Bank Payment-gateway) in case of payment through ICICI Bank i) Payment Gateway.
 - RTGS/NEFT in case of offline payment through bank account in any Bank .
