#### **Earnest Money Depositof e-Procurement**

1. General guidance for e-Tendering

Instructions / Guidelines for tenders for electronic submission of the tenders online have been annexed for assisting the contractors to participate in e-Tendering.

2. Registration of Contractor

3. Digital Signature certificate (DSC)/e-Token

Each contractor is required to obtain aDigital Signature Certificate (DSC)/ e-Token for submission of tenders from the approved service provider of the National InformationCentre(NIC) on payment of requisite amount, details are available at the Web Site.

4. The Contractor can search &download e-NIT & Tender Documents electronically from computer once he logs on to the website mentioned in clause 2 using the Digital Signature Certificate)/ e-Token. This is the only mode of

collection of Tender Documents.

5. Participation in more than one work

A prospective tenderer shall be allowed to participate in the work either in the capacity of individual or as a partner of a firm. If he is found to have applied severally in a single work all his applicants will be rejected for the work.

6. Submission of Tenders.
