NOTICE INVITING E-TENDER

For and on behalf of Panchayats and Rural Development Department, Govt. of West Bengal, the Purba Bardhaman Zilla Parishad invites E-Tender in percentage rates for each of the following construction work under Purba Bardhaman Zilla Parishad by two cover system. Resourceful and Bona-fide contractors of Government/Semi Government/Undertaking/Autonomous Bodies/Statuary Bodies and Local Bodies who satisfy the terms and conditions set out in pre-qualification document and having registration in e-procurement portal (https://www.wbtenders.gov.in) under Govt. of West Bengal may submit their bids. The intending bidders must have completed one Civil Engineering Project of value not less than 40% of the estimated amount put to tenderin last 5 years from the date of issue of this NIT in which Feacal Sludge and Septage Treatment Plant / Effluent Treatment Plant is a part of the project OR one single running work of similar nature which has been completed to the extent of 90% or more (substantially completed) and value of which is not less than the value of 40% of the estimated amount put to tender of intended job. The intending bidders should possess proper Electrical License & must have Mechanical & Electrical Engineer in their Payroll. Bidder should submit details of Feacal Sludge and Septage treatment Plant/ Effluent Treatment Plant duly approved by Client.

The pre-qualification documents are to be uploaded in two separate folders. One of the folders shall contain Technical documents. Financial Bids are to be uploaded in another folder. The Tenders shall be available for viewing in our website https://www.wbtenders.gov.in

- 2) Tender Inviting Authority will not take any responsibility for the delay caused due to non-availability of internetconnection or traffic jam etc. for on-line bidding.



- 3) Earnest Money/ Bid Security: Cost of Bid Security/ Earnest Money should be deposited. (in case of EM exemption is provided by Finance Department vide Order No. 6417-F(Y) Dated, The 26th August 2015, Gov of West Bengal. The Bidder eligible for exemption of EMD as per Govt. Order mentioned above, may avail the same and necessary document regarding the Exemption of EMD must be uploaded).
 - a) Net banking (any of the banks listed in the ICICI Bank Payment gateway) in case of paymentthrough ICICI Bank Payment Gateway.
 - b) Exemption of Farnest Money will be applicable as per existing order of the Finance Department, Go of West Bengal Vide Order No. 6417-F(Y) Dated, The 26th August 2015.
- 4) The pre-qualification (Tennical Bids) documents will be opened on 21.08.2024 at 16:00 Hours by the District Engineer, Purba Bardhanan Zilla Parishad in presence of bidders.
- 5) Tender Inviting authority reserves the right to call for original document for verification from successful bidder(s) only in case of exceptional circumstances.
- 6) The results of the technical evaluation shall be made public on e-procurement systems following which there will be a period of 48 hrs during which any bidder may submit **complaint** which shall be considered for resolution before opening the financial bid.
- 7) The Financial bid of the technically qualified bidders will be opened for evaluation and the financial bid of non-qualified bidders will remain unopened. No separate intimation will be given for this, unless the above date is changed. In case of change of date, due intimation will be given on-line only.
- 8) Tender Inviting authority reserves the right to accept or reject any bid, and to cancel the bidding process and reject all bids, at any point of time prior to the issuance of work order, without thereby incurring any liability to the affected bidder or bidders or any obligation to inform the affected bidder or bidders of the grounds for the authority's action.
- 9) Acceptance of Tender (AOT) / LOA will be issued after approval of competent authority.
- 10) GST, Cess, Taxes and Duties etc. if any at applicable rates will be deducted from the bill of the contractor.

11) Additional Performance Security in Projects

If the rate offered by agency is beyond 20% less, the bidder shall have to deposit additional performance security @ 10% of tendered amount in the form of Bank Guarantee from any Scheduled Bank before issuance of work order in favour of "Finance Controller & Chief Accounts Officer, Purba Bardhaman Zilla Parishad" and which will be released after successful completion of the work. This Bank Guarantee shall have to be valid up to end of the Contract Period and shall be renewed accordingly, if required.

OR

If the rate offered by agency is beyond 20% less, the bidder shall have to deposit additional performance security @ 10% of tendered amount in the form of Bank Draft from any Scheduled Bank before issuance of work order in favour of "Finance Controller & Chief Accounts Officer, Purba Bardhaman Zilla Parishad" and which will be released after successful completion of the work. This Bank Guarantee shall have to be valid up to end of the Contract Periodand shall be renewed accordingly, if required.

12) The Security Deposit money of successful bidders will be released full or in part during/after expiry of defect liability period from the actual date of completion of the work as per norms stated in "Other Instruction", Instruction to Bidder (ITB). Contractor may be allowed to withdraw the Security Deposit in lieu of Bank Guarantee of requisite amount valid for entire defect liability period.

Any damages occurred during defect liability period will have to be done by the contractor at his own cost. in this respect Clause 17 of the General condition of contract in the Standard Bidding document following west Bengal form no 2911 shall be substituted with the following vide Memo No. 5784-PW/L&A/2M-175/2017 Dt- 12.09.2017 of Law & Arbitration cell, Public Work Department, Govt. of West Bengal.

Clause 17 - If the contractor or his workmen or servants or authorized representatives shall break, deface, injure, or destroy any part of building, in which they may be working, or any building, road, road-curbs, fence, enclosure, water pipes, cables, drains, electric or telephone posts or wires, trees, grass or grassland or cultivated ground contiguous to



thepremises, on which the work or any part of it is being executed, or if any damage shall happen to the work from any cause whatsoever or any imperfection become apparent in it at any time whether during its execution or within a period of three months or one year or three years or five years, as the case may be (depending upon the nature of the work as described in the explanation appended hereto) hereinafter referred to as the Defect Liability Period, from the actual date of completion of work as per completion certificate issued by the Engineer-in-Charge, the contractor shall make the same good at his own expense, or in default, the Engineer-in-Charge may cause the same to be made good by other workmen and deduct the expense (of which the certificate of the Engineer-in-Charge shall be final and binding on all concerned) from any sums, whether under this contract or otherwise, that may be then, or at any timethere after become due to the contractor from the Government or from his security deposit, either full, or of a sufficient portion thereof and if the cost, in the opinion of the Engineer-in-Charge (which opinion shall be final and conclusive against the contractor), of making such damage or imperfection good shall exceed the amount of such security deposit and/or such sums, it shall be lawful for the Government to recover the excess cost from the contractor in accordance with the procedure prescribed by any law for the time being in force.

- 13) The intending Bidders should satisfy himself about the alignment of the proposed road site and other site condition by visiting the site before quoting their rates.
- A) The eligibility criteria are given below:

The applicant in the same name and style should have achieved annual turnover in any of the year over the last five years (in all cases of civil engineering construction works only). The turnover will be indexed at the rate of 8 percent simple interest for a year. (The respective payment certificates are to be attached)

- a) 60% of amount put to bid, in case the amount put to bid is Rs. 200 lakhs and less.
- b) 75% of amount put to bid, in case the amount put to bid is more than Rs. 200 lakhs.

1. The applicant in the same name and style as prime contractor must have completed one Civil Engineering Project of value not less than 40% of the estimated amount put to tender in last 5 years from the date of issue of this NITin which Feacal Sludge and Septage Treatment Plant/ Effluent Treatment Plant is a part of the project OR one single running work of similar nature which has been completed to the extent of 90% or more (substantially completed) and value of which is not less than the value of 40% of the estimated amount put to tender of intended job. The intending bidders should possess proper Electrical License & must have Mechanical & Electrical Engineer in their Payroll. Bidder should submit details of Faecal Sludge and Septage Treatment Plant/ Effluent Treatment Plant duly approved by Client. In case the bidder does not possess any Electrical Licence, they may enter into an project specific agreement with other Contractor having Electrical Licence.

- 2. The contractor should have sufficient technical manpower, tools and plants to complete the work
- 3. The prime contractor should have necessary bid capacity to execute the work. (Bid capacity will be calculated for workvalued more than 1 Cr.)
- 4. Financial statements for the last 03 (three) years (Audited if applicable).
- 5. Income Tax return should be submitted for last 3 years.
- 6. GST registration Certificate, Professional Tax registration certificate, Card (Income Tax), Trade license should befurnished.
- 7. No CONDITIONAL/INCOMPLETE TENDER will be accepted under any circumstances.
- 8. The bid of Any Black listed agency will not be accepted.
- 9. Arbitration will not be allowed in any case.
- 10. Prospective applicants are advised to note carefully the documents to be uploaded for qualification as mentioned in the"Instruction to Bidder' before bidding.

The amount of earnest money is 2% of the estimated cost of construction or Rs. 10.00 lakhs whichever is lower (cl.11.1 of GCC form no 2911). [Exemption of Earnest money will be applicable as per existing order].

All duties, GST, taxes, royalties, cess, [including 1% cess under W.B. Road/Building and other Construction Workers (Regulation of Employments & Condition of Service) Act, 1996], toll, taxes and other levies payable by the Contractor under the Contract to the State / Central Government for any other cause, shall be included in the rates, prices and total Bid price submitted by the bidder.

To keep the constructed road/building in good condition during the Defect Liability period after the completion of the construction if any work is required for routine maintenance, the same will be treated as defect liability and the Contractor has to do the maintenance work at his own cost.

8. Turnover of last 5 Financial Year duly signed by Auditor. The Turnover will be indexed at the rate 8 percent simple interest for a year.

9. Credentials for successful completion certificates from the Appropriate authority (not below the rank of Executive Officer, Panchayat Samity) of at least one Civil Engineering Project of value not less than 40% of the estimated amount put to tender in last 5 years from the date of issue of this NIT in which Feacal Sludge and Septage Treatment Plant/ Effluent Treatment Plant is a part of the project. The intending bidders should possess proper Electrical License & must have Mechanical & Electrical Engineer in their Payroll.

The prospective bidders should produce credential As A SOLE FIRM (NOT as a sub-Contractor) at least one single running work of similar nature which has been completed to the extent of 90% or more (substantially completed) and value of which is not less than the value of 40% of the estimated amount put to tender of intended job under the authority of state/Central Govt. State/Central Govt. undertaking, Statutory/Autonomous Bodies Constituted under the statute of the Central/State Government. In the Credential Certificate it should be clearly stated that the work is in progress satisfactorily & also that no penal action has been initiated against the executed agency.

- 10. In case, Bidder is submitting the credential of a Private Entity, then 26AS to be uploaded in support of Payment received from Client to fulfill the technical eligibility Criteria.
- 11. All tools and plants required for the work will have to be supplied by the contractor at his own cost. The list of machineries as indicated in clause (B1 of ITB) possessed by own/ arranged through lease deed along with Authenticated copy of invoice/ Challan as per ITB. (For work valued more than 1 Cr.)
- 12. List of ongoing works in hand and the Physical and financial progress of those works as per Annexure-C. (For work valued more than 1 Cr.)
- 13. Scanned copy of Bid Capacity calculation in his/her own letter head. (Calculation to be done as prescribed annexure -B) (For work valued more than 1 Cr.)
- 14. Tender form and NIT with all addendum and corrigendum to be uploaded will be (download and digitally signed. Quoting rate will only encrypted in the B.O.Q under financial bid. In case quoting any rate in printed tender form, the tender will be summarily rejected)
- 15. Special terms and conditions and specifications of work.
- 16. Partnership firm shall furnish partnership deed and company shall furnish the Article of Association and Memorandum.
- 17. The registered cooperative societies should submit the registration certificate.
- 18. Power of attorney (in case of Partnership firm /Registered Co-Operative Society/company) to be uploaded.
- 19. Notaried Affidavit in non-judicial stamp paper regarding non employment of any Government official under him, deployment of machineries, laboratory equipment; technical personnel, correctness of certificates, and investment of minimum cash up to 30% of estimated cost etc. as per annexure-A.
- 20. Letter head of the agency/contractor containing Name addresses and contact details. During the currency of the project and after completion if the address of the agency/contractor changes, it will be the responsibility of the contractor to intimate the authority regarding such changes.



- 21. Work program in terms of bar chart to be submitted. (For work valued more than 1 Cr.)
- 22. Bank Credit Certificate of 10% of the Amount put to tender should be provided as per format. (Format Attachedas annexure D). (For work valued more than 1 Cr.)

C. Other instructions

- 1. Before the deadline for submission of bids, the Employer may modify the bidding documents by issuing addenda.
- 2. The unit rates and the prices shall be quoted by the bidder entirely in Indian Rupees.
- 3. No Mobilization Advance and Advance against purchase of equipments will be paid for the work.
- 4. No Advance of any kind will be paid for the work under any circumstances.
- 5. Under no circumstances Escalation in prices in materials, labour charges, cost of P.O.L. & arbitration willbe entertained.
- The Employer requires the bidders / Contractors to strictly observe the laws against fraud and corruption inforce in India, namely, Prevention of Corruption Act, 1988.
- 7. There will be no price preference to any bidder.
- 8. No interest claim will be admissible during refund of earnest money and security deposit.
- Uploaded documents of valid successful bidders may be verified with the original in due course. The valid successful bidders have to show the originals to the concerned authority as and when required.
- 10. Any bill (running account/final) payment of proposed executed work may be made to Agency as per availability of fund.
- 11. Bid of any Black listed bidder will be rejected.
- 12. The engaged contractor will have to get registered under BOCW (RECS) act and shall have to contribute towards "
 The West Bengal Building and other Construction Workers' welfare fund" @ 1% (One percent) of the gross amount
 of the work by way of deduction from Running and /or final bill.
- Earnest Money & Security Deposit: The Earnest Money (2% of amount put to tender) will be converted to Security deposit. The Balance amount of Security Deposit (as per Govt. order in force during pendency of the contract) money will be deducted from running and final bill. Exemption of Earnest Money will be applicable as per existing order of the Finance Department, Govt. of West Bengal.
 The Security Deposit will be released to the contractor as stated below.
 - (a) For work with three months Defect Liability Period:
 - i) Full security deposit shall be refunded to the contractor on expiry of three months from the actualdate of completion of the work.
 - (b) For work with one year Defect Liability Period:
 - i) Full security deposit shall be refunded to the contractor on expiry of one year from the actual date of completion of the work.
 - (c) For work with three years Defect Liability Period:
 - i) 30% of the security deposit shall be refunded to the contractor on expiry of two years from theactual date of completion of the work;
 - ii) The balance 70% of the security deposit shall be refunded to the contractor on expiry of three years from the actual date of completion of the work;
 - (d) For work with five years Defect Liability Period:
 - i) No security deposit shall be refunded to the contractor for 1st 3 years from the actual date of completion of the work;
 - ii) 30% of the security deposit shall be refunded to the contractor on expiry of four years from

theactual date of completion of the work;

- iii) The balance 70% of the security deposit shall be refunded to the contractor on expir offive years from the actual date of completion of the work; Contractor may submit Bank Guarantee of requisite amount for the entire Defect Liability period to withdraw Security Deposit amount.
- 15. Bidder is responsible for the entire Civil and Electro Mechanical works and smooth functioning ofproject upto the end of specified maintenance period.
- 16. No Joint Venture/ authorizing letter shall be entertained.
- 17. Time allowed for completion of work will be measured from the date of issue of work order
- 18. If any erroneous printing found after agreement or any time in the SOQ (Schedule of Quantity) Quantity or Rate, the Tender Inviting authority reserve the rights to correct the same as per approved original estimate.
- 19. Bidding documents (NIT and SBD) is to be uploaded by the bidder. The bidder has to only agree/ disagree on the conditions in the bidding document. The bidders who disagree on the conditions of bidding document cannot participate in the tender and his /their bid will be treated as informal.
- 20. Even though the bidders meet the above qualifying criteria, they are subject to be disqualified if they have:
 - (i) Made misleading or false representations in the forms, statements, affidavits and attachments submittedin proof of the qualification requirements; and / or record of submission of any false / fake
 - (ii)Record of poor performance such as abandoning the works, not properly completing the contract, inordinate delays in completion, litigation history, or financial failures etc.
 - (iii) Participated in the previous bidding for the same work and had quoted unreasonably high or low bidprices and could not furnish rational justification for it to the Employer.
- 21. Bidders who meet the minimum qualification criteria will be qualified only if their available bid capacity for construction work is equal to or more than the total bid value. The available bid capacity will be calculated as per annexure-B.
- 22. The successful bidder shall have to abide by all the labour related and other rules, regulations and laws of the land and the Tender Inviting Authority in no way shall be held responsible for financial or any other consequences arising out of non his noncompliance of the same.
- 23. Intending Bidder should read carefully read the Cl No 41 of GCC regarding the suspension and debarment policy before participating the tender.
- 24. Tax Invoice needs to be issued by the agency/contractor for raising claim showing separately the tax charged in accordance with the provisions of GST Act, 2017.
- 25. Contractor should have to ensure the engagement of JOB CARD holders as unskilled workers for execution of

- At any time after the successful completion of the Tests on Commissioning, the Bidder may give a notice to the Purba Bardhaman ZP requesting the issue of an operational acceptance certificate ("Operational Acceptance Certificate") in respect of the Faecal Sludge & Septage treatment plant.
- The Purba Bardhaman ZP shall, after consultation with the experts, and no later than 7 (seven) days after III. receipt of the Bidder's notice, issue an operational Acceptance Certificate.
- If within 7 (seven) days after receipt of the Bidder's notice, the Purba Bardhaman ZP fails to IV.
- Issue the Operational Acceptance Certificate or fails to inform the Bidder in writing of the justifiable reason why the ٧. Purba Bardhaman ZP has not issued the operational Acceptance Certificate, the Faecal Sludge & Septagetreatment plant shall be deemed to have been accepted as of the date of the Bidder's said notice.

burba Bardhaman ZP shall take out necessary Insurance Policy/ Policies so as to provide adequate insurance cove. The insurance should cover for the following:

Loss of or damage to the civil and mechanical and electrical equipment supplied/ installed including the

materials such as pipes, valves, specials etc. brought on site;

Loss of or damage to Bidder's equipment including his vehicles;

Loss of or damage to property (except the work, plant material and equipment) in connection with the c) Bidder;

Loss of or damage to property (except the work, plant material and equipment) in connection with the d)

Bidder; and

- Personal injury or death due to vehicles of the Bidder and / or due to any accident that may arise at or around Site to the Bidder's personnel or to the Purba Bardhaman ZP staff or to any other person connected with Purba Bardhaman ZP Bidder.
- Policies and certificate of insurance shall be delivered by the Bidder to the Engineer for the Engineer's approval before the date of actual starting of Work. insurance for which the Bidder was responsible

The minimum insurance cover for loss and damage to physical property, injury and death shall be 10% (ten percent) of the Contract cost per occurrence with number of occurrences as 4 (four). After each occurrence the Bidder shall pay additional premium necessary so as to keep the insurance policy valid always till the defect liability period is over.

Contractors all risk (Bidder's all risk policy) insurance will have to be taken before start of the Work. i)

Clause No 25: Commissioning and trail run of Faecal Sludge & Septage Treatment plant

The plant shall then be on trial operation of 30 days during which period all necessary adjustments shall be made while operating, over the full load-range enabling the plant to be made ready for performance and guaranteetests. The contractor shall provide necessary staff. The trail operation shall be considered successful, provided that each item of the equipment can operate continuously at the specified characteristics, for the period of Trail Operation.

b) Bidder shall be responsible for carrying out all the necessary pre-commissioning tests. On completion of inspection, checking and after the pre-commissioning tests are satisfactorily, over the complete plant shall be placeson initial operation during which period the complete equipment shall be operated integral with sub-systems and

supporting equipment as a complete plant.

Any special equipment, tools and tackles required for the successful completion of the performance and

guarantee tests the contractor will provide this free of cost.

The contractor during the performance and guarantee tests shall provide the guaranteed performance figures of the equipment. Should the result of these tests show any decrease from the guarantee values, the contractor shall modify the equipment as required to enable them to meet the guarantees. In such case, performanceand guarantee tests shall be repeated within one week from the date the equipment is ready for re-test and cost formodifications including labor, materials and the cost of additional testing to prove that the equipment meets the guarantees, shall be borne by the contractor.

OPREATIONAL SERVICES

1 Introduction

The bidder shall ensure the operation and maintenance of the FSTP in compliance to the CPHEEO Manual on "Sewerage & Sewage Treatment", published by the Central Public Health Environmental Engineering Organization (CPHEEO), Ministry of Urban Development, Government of India, New Delhi and the prescription laid down hereunder.

2 Scope of Work

The Bidder shall operate and maintain the Faecal Sludge & Septage treatment plant, and all other allied works under this contract, for a period of 5 (five) years and provide the following service ("Operations Services"). Salient features of Operations Service are:

After construction of the Faecal Sludge & Septage treatment plant, the Bidder shall operate and maintain FSTP plant as per specifications and maintain the quality of the treated effluent as prescribed in the DesignBuild Documents.

- The Bidder will monitor the performance of the Faecal Sludge & Septage treatment plant; conduct the analysis of the inlet septage and effluent/septage quality after treatment. Bidder shall initiate and take adequate actions to ensure smooth and satisfactory performance / running of the plants on a 24 hours / round the clock basis.
- The Bidder shall prepare and implement an effective plant maintenance programme in consultation with the Purba Bardhaman ZP. It is an absolutely Bidder's responsibility to look after all sorts of maintenance whether preventive, minor, major or break-down.

The Bidder will determine operating parameters, and generally optimize the process, and working of the

The Bidder should plan & procure all spares and all consumables including chemicals, grease, lubricating oil, cleaning agents, laboratory reagents etc.

The Bidder will be responsible for keeping up-to-date record of documents including history card for equipment and maintaining every day log book relating to various analyses performed.

The Bidder at his/her own cost shall maintain and update logbook, in which details of operational parameters are

recorded at regular interval as decided mutually.

The FSTP will accept septage load from suction trucks from time to time in a day from 06:00 am to 11:00 pm, beyond which it should not accept septage load. Also, it should accept load only from the authorized contractor of Purba Bardhaman ZP only.

The Bidder will prepare and submit a daily report of plant performance and will assist the Purba Bardhaman

ZP in preparing the necessary documents for their purpose and records.

- The Bidder will be responsible to carry out day to day periodic maintenance, necessary to ensure to smooth and efficient performance/running of all equipment / instruments comprising the Faecal Sludge treatment plant and maintaining record of the same.
- The Bidder shall have to issue identity cards with photographs to all the staff employed for operation and maintenance. The list of the same shall be submitted to the Purba Bardhaman ZP mentioning qualification &

The Bidder will also be responsible to carry out day to day maintenance inside the Faecal Sludge & Septage treatment plant premises.

- The Bidder will employ required staff for operation and maintenance of the Plant as per the list submitted by bidder in their proposal during 5 years of O&M period. The staff of Bidder will always remain in contact with the Junior Engineer, Assistance Engineer/Electrical Supervisor, in charge of the Plant deployed by the ZP and follow their instruction.
- Unsatisfactory and inefficient running of the plant and unnecessary and excessive usage of spare, consumable, etc. supported by the reason which are under control of Bidder will be highly objected. In suchcases Purba Bardhaman ZP decision will be final and binding to the Bidder.

Bidder will comply with all safety rules and regulations and all inter disciplinary as followed by the Purba

- The Purba Bardhaman ZPwill not be responsible for any accident / injury to the staff of the Bidder. Further the Purba Bardhaman ZP willnot provide any insurance or medical facility to the staff of Bidder. The responsibility lies with the Bidder.
- ALL central/State Government/Semi-Government/ Local Body's Rules and Regulations pertaining to this contract shall be followed and observed by the Bidder without any extra cost to the Purba Bardhaman ZP.
- No accommodation / guesthouse / transportation facility will be provided by Purba Bardhaman ZP to the Bidder. Operation& maintenance staff will not be allowed any accommodation facility inside the premises.

The Bidder should employ all the staff within 7 (seven) days of successful commissioning.

The Bidder will provide the necessary tools and tackles required for day-to-day maintenance.

- The scope of work also includes cleaning of complete plant area including floor, toilet block railing, door, windows, light fixtures and ceiling etc. The entire premises of the plant area shall also be cleaned and maintain by the Bidder regularly.
- This work is inclusive of but not limited to operation, maintenance, housekeeping, cleaning, removing sludge by its own carrier arrangement & disposes it off as per Purba Bardhaman ZP instructions.
- BOQ Tender Document for Faecal Sludge & Septage Treatment Plant will be available Zilla Parishad web site Preparing data recording, correspondence work to Purba Bardhaman ZP and Government departments, etc. All this work should be done as per standard practices and by following labor, factory, electrical and all other old and newlaw and order, Indian standards etc. as applied of Local, State and Central Government of India.
- Right is reserved by Purba Bardhaman ZP for suspension, dismissal, termination of any office / staff employed by Bidder. Heshall have taken prior permission to employ or to terminate his personnel.
- No watch and ward, safety insurance, security, storage, housing accommodation etc. will be provided by Purba Bardhaman ZP. This will be responsibility of Bidder.
- Consumable items like rubber bush, graphite packing, rubber sheet, nut-bolts and material require for cleaning and housekeeping etc. are to be brought by the Bidder.
- Electricity charges including diesel in case of power failure required for operation & maintenance of the Plant shall have to be borne by the Bidder. The Bidder should provide



All other consumables like polyelectrolyte, chlorine, oil & grease etc. All the formalities to all Government authorities for factory, electrical, etc. for obtaining no objection certificate, water consent, hazardous waste

concern, approval etc. shall be done by the Bidder.

Monitoring should be done as per guidelines provided by Purba Bardhaman ZP. Bidder has to maintain all the parameters of effluent within stipulated limit or he will be penalized for not maintaining the prevalent discharge standards of state Government and as amended from time to time. All expenditure incurred for the same like, suit fee, court fee, case fee, or the penalty as decided by Engineer of Purba Bardhaman ZP and penalty charged by relevant government authority will be charged to Bidder and deducted from his bills, security Deposit etc.

Bidder shall have to test the effluent / influent at his own cost at the government approved laboratory as per schedule mentioned in bid document. The same be verified by and checked by Purba Bardhaman ZP whenever

The payment of O&M charges will be made as per the tender conditions which are mentioned in B.O.Q. The other terms and condition described in these complete tender documents, wherever applicable shall remain unchanged. In case of any discrepancy the decision of Purba Bardhaman ZP will remain final & binding on

During O&M period, Bidder has to supply all the spares, at his cost during preventive major-minor breakdown, replacement and maintenance work. No extra payment will be made for such maintenance on any ground. The payment for the same will be made strictly as per tender documents irrespective of the number of break down /minor, major repairs replacements. During the O&M period, the Bidder will have to enter into annual maintenance agreement with manufacturers of all major mechanical equipment.

Maintenance of garden, lawns plants, bushes, plantation of new plants, lawns etc. and feeding, gardening,

cleaning etc. is in the scope of the Bidder. No separate payment will be made for the same.

The Bidder during his O&M period will have to follow all the guidelines set by relevant government authority of West Bengal state for operation & maintenance of Faecal Sludge & Septage treatment plant.

Operation and maintenance of all General facilities and utility services including all other components of work

The Bidder shall also dispose of the sludge, screenings, grit and any other material, as per specifications and to the satisfaction of the Purba Bardhaman ZP. It is to be noted that all costs during the O&M period, including the cost of power and chemicals are to be borne by the Bidder.

Within his quoted cost, the Bidder is to ensure that guarantees are maintained during the O&M Period for

quality of treated effluent, treated septage, consumption of chemicals and for automation.

The Bidder shall provide on job training to the local body staff as per specifications.

- At the end of every year of operation & maintenance period, an assessment of the condition of the plant hasto be done by the Bidder through third party inspection at his own cost and based on that assessment the Bidder shall, at no extra cost to the Purba Bardhaman ZP, repair and re-condition all the mechanical equipment in the concluding year of the O&M contract to a condition so that they are in running condition with regular preventive and recommended maintenance as per manufacturer's recommendations or as per CPHEEO
 - Variability of Throughput: If the quantity of treated septage from the Plant increased in the existing system without impacting the annual fixed costs to the Bidder, the Bidder shall comply with such requirements.

3 TESTS TO BE CARRIED OUT DURING O&M PERIOD

Sampling and testing to be carried out as per CPHEEO guideline. Tests are to be carried out under the supervision of qualified staff and as per instructions of the Engineer-in-charge. The responsible employee of the contractor will indicate the details of sample locations timings on the sample template.

The Bidder should get analyzed / checked the untreated as well as treated septage and effluent samples and tested in approved government laboratory at his own cost. The Purba Bardhaman ZP Vigilance testing charges for samples directly collected by Purba Bardhaman ZP are also to be borne by the Bidder.

During routine monitoring, samples of influent, effluent as analyzed based on the Analysis Schedule given in the following Table for the given parameters.

Test parameters of treated quality shall be within the prescribed limits as issued by West Bengal Pollution Control Committee for STP/FSTPs.

A. Staff

The Bidder shall mention the number and nature of personnel required for O&M in his bid. Non-employment of thosepersonnel during O&M as per the Bid will lead to imposition of penalty as mentioned Contract data.

B. Safety / Security

The Bidder shall take all safety precautions under carious acts/Rules under central/State Govt. from time to time andhe shall be responsible for safety of its staff and the consequences thereof. The Bidder shall deploy round the clock security personnel at entrance of Plant's premises and in the compound for the safety of the Plant premises for the safety of the Plant, equipment and personnel during this period.

C. Responsibility for damages

The Bidder shall ensure that the staff employed takes all necessary precautions while carrying out the work either inshift duties or any general shift as per Indian Electricity Rules/Factory Act/ CPHEEO Manual, or manufacturer's special instruction for safety / gas handling. The staff should use gas masks, oxygen apparatus, gum boots, safety belts and safety lamps, etc. while carrying out the work in bar screens, sumps etc.

D. Reporting

The Bidder at its own cost will prepare and paint daily and monthly reports (in approved Purba Bardhaman ZP format) of pumping/treatment and project performance and submit to the Purba Bardhaman ZP and will assist the department in preparing the necessary documents for their purpose and record as per proforma given from time to time. The reports shall contain, inter-alia, the following:

Raw Septage quantity and quality and effluent quality as per the monitoring format and other tests as specified in this section shall be submitted to Engineer-in Charge. Treated quality to septage and effluent as per monitoring format and shall be submitted to Engineer-in charge. The plant manage shall verify the daily record as well as the calculations and shall be responsible to generate further data using these.

- A description of the maintenance work carried out in the reporting period.
- A report on major failures, if any, their causes and remedial action taken.
- Sludge quality and quantity (daily basis) in the reporting period.
- Power and chemicals consumed in the reporting period.
- An inventory of the chemicals and spare parts available at the end of the reporting period.
- O&M staff deployed by the Bidder during the reporting period.
- Any major repair works, if any.
- Bidder is required to maintain separate register/computerized records at all sites of following information:
 - i. Pumping register
 - Quantity of septage/ sewage treatment and performance register ii.
 - iii. Working hours register
 - iv. Electric break down register
 - Maintenance register
 - Staff attendance register



Site Order Book

Site order book shall be kept by the Engineer-In-Charge at the Plant site. Orders entered in this book by the Purba Bardhaman ZP or his authorized representative shall be held to have been formally communicated to the Bidder. The Engineer-In-Charge or his authorized representative shall sign each order as it is entered and will hand over the duplicate to the Bidder or his agent, who shall sign the original in acknowledgment of having received the order.

F. Technical Audit

The Purba Bardhaman ZP has the right to conduct a technical audit of the Plant and to perform any analysis or inspection he deemsnecessary. The Bidder shall at his cost provide all assistance the Purba Bardhaman ZP required to complete these inspections. Suchaudits may cover all or any of the obligations of the Bidder, including without limitation,

Verification of the system capacity and save for normal wear and tear during the O&M Period.

 Verification of the performance standards and useful life of the individual assets of the Facility, save for normal wear and tear during the O&M Period.

 Verification of the capacity of the Plant to meet output standards during the residual life of the Plant and save for normal deterioration expected during such residual life.

• Sampling, testing and verification of the output standards for treated septage / effluent.

G. Operation and Maintenance Manual

The Bidder shall prepare a detailed program (referred to as O&M Manual) covering the operation and maintenance of the treatment plants as a whole.

The O&M Manual shall include the daily, weekly, monthly, quarterly, half yearly and annual checks and remedies if necessary to be performed for effective operation of the plant, elaborate details

operating and maintenance procedures and policies which are required, advisable and / or necessary of the FSTP facility to achieve full compliance with the operational guarantees and to achieve maintenance and repair standard for the Facility which will ensure compliance with the maintenance specification. The O&M manual shall include inter alia full explanation of all plant procedures and processes.

Without limiting the generality of the foregoing, the O&M Manual shall include descriptions, procedures and shall comply with the requirements, set forth in the provisions of the Bid Documents.

The draft of the O&M Manual shall be subject to the review and approval of Purba Bardhaman ZP, which shall have the right to makeany changes and revisions to the O&M manual as it may deem appropriate. The Bidder shall revise such draft O&M Manual prior to the commencement of the O&M period.

At the end of the construction period, the Bidder shall revise the draft O&M Manual to reflect any updates, changesor revisions it deems appropriate, inter-alia based on its experience and as necessary to reflect any modifications or adjustments to the plant.

Without limiting the above, the Bidder shall annually fully review, revise, update and modify the draft O&M Manual as may be necessary or appropriate. Any revision to the draft O&M Manual shall be subject to the review and approval of Purba Bardhaman ZP.

Purba Bardhaman ZP shall have the right to require revisions to the draft O&M Manual as it may deem appropriate. The Bidder shallprepare and submit to Purba Bardhaman ZP, for its review and approval, 30 days prior to the proposed date of commencement of O&M, q revised draft O&M Manual which reflects all changes, revisions and modifications. The Bidder shall prepare the O&M Manual, as approved by the Purba Bardhaman ZP, prior to the start of O&M.

H. TRANSITION PLAN - Taking Over

The transition plan shall include,

- a) Plans to transfer the Faecal Sludge & Septage treatment plant to the subsequent operator as designated by the Purba Bardhaman ZP;
- b) Transition plans with respect to the Operator's personnel including a plan for transition of the Operator's personnel to a subsequent operator;
- c) A proposed process for the transfer of all Contract records to the Purba Bardhaman ZP;
- d) Plans to transfer operations and maintenance functions to the subsequent operator and
 e) A program to train staff of the Purba Bardhaman ZP in all aspects of the operation and maintenance of the Plant and thefacilities.
