1. Scope of Work

- i. Traffic Study Classified Traffic Volume Count for Continuous 3 days at 1 location as specified above shall be carried out following latest IRC guidelines including Preparation of traffic analysis report.
- ii. The successful bidder (consultant) shall use Automated Traffic Count and Classification system (ATCC) that can meet the following accuracy levels:

After validation / correction:

- a) Classification of vehicles: Better than 95 %
- b) Counting of Vehicles: Better than 98 %

Before validation / correction:

- a) Classification of vehicles: Better than 90 %
- b) Counting of Vehicles: Better than 95 %

For verification of above accuracy levels, audit of raw ATCC shall be done on a sampling basis.

- iii. ATCC systems such as Pneumatic Tube Detector, Inductive Detector Loop, Video Image Detection, and Infrared Sensor or equivalent technologies shall be adopted.
- iv. The vehicle classification system as given in relevant IRC code may be followed. However, the generalized classification system for Motorized (2-Wheeler, 3-Wheeler) (Passenger Car, Utility Vehicle such as Jeep, Van etc.), (Mini Bus, Standard Bus), (LCV-Passenger, LCV- Freight, MCV 2-Axle Rigid Chassis), (HCV 3-Axle Rigid Chassis, MAV Semi Articulated & Articulated) is suggested in view of the requirements of traffic demand estimates and analysis.
- v. All results shall be presented in tabular and graphical form. The survey data shall be analyzed to bring out the hourly and daily variations. The traffic volume count per day shall be averaged to show a weekly

average daily traffic (ADT) by vehicle type. The annual average daily traffic (AADT) shall be worked out by applying seasonal factors.
